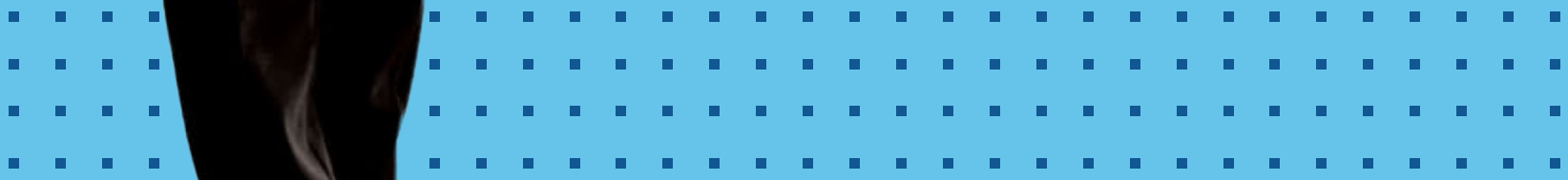

# NACD Atlanta Chapter

Our journey is picking up speed. Our chapter brand vision several years ago was to become the center of gravity for board development excellence in the Atlanta business ecosystem.

The depth and quality of our leadership board and our sponsors has helped us build relationships and trend leading programming with the Federal Reserve, Delta Airlines, Emory University, the University of Georgia, the Atlanta Metro Chamber, Home Depot, private equity firms, Coca-Cola Co., Business Executives for National Security, the Atlanta Business Chronicle, and UPS just to name a few.

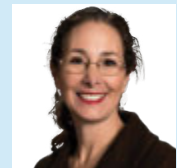

# NACD Carolinas Chapter

**B**ased in Charlotte, our not-yet-10-year-old chapter has continued to grow and mature through the difficulties of the past few years. The COVID-19 pandemic jolted our familiar cadence of local panel discussions and incentivized us to test, learn, and innovate our programming and member engagement. Our efforts have driven strong attendance and membership engagement growth while attracting a record number of premium sponsors and committed board members. We adapted to deliver the NACD's mission of empowering directors and transforming boards in the Carolinas—and beyond.

## YOUTHFUL CHAPTER WITH SOLID FOOTINGS

Chartered in March 2013, NACD Carolinas is the newest of NACD's independent chapters. Organized two years earlier, as a satellite of the Research Triangle Chapter, founding Chapter President Sue Cole (now NACD board chair) and eight local directors successfully championed Charlotte's importance as a business hub and gateway to both Carolinas as a basis for the new chapter.

The Carolinas Chapter soon settled into a cadence of six core programs and occasional dinners, with annual attendance in the mid-to-high 200s. It benefitted from a strong, continuing base of sponsors and founding director presence through 2019.

## INNOVATING PROGRAMMING TO STAY RELEVANT

Looking back, the year 2020 started with a prescient topic for our only in-person program: "Preparation for an Economic Downturn: It's Not If, But When." The COVID-19 pandemic soon rocked the US economy and shut down meetings. Like others, we pivoted our program delivery to virtual, ultimately delivering 10 planned programs and cosponsoring a joint chapter two-part virtual round table on Black chapter presidents' perspectives on race relations. In our year-end tally, our virtual chapter programs had sustained similar-sized attendance (approximately 35 people per event) while the joint programs exposed us to a national director audience.

In 2021, we introduced a new blockbuster, "Take It from the Top" series, focused initially on our corporate board member companies

and then broadened to feature other Carolinas leaders in intimate fireside chats. The series delivered our three highest attendance programs (more than 100 each) with a national draw: Sue Gordon, former principal deputy director of National Intelligence; Brian Moynihan, Bank of America chair and CEO; Tom Barkin, Federal Reserve Bank of Richmond president and CEO (chapter year 2022).

This year has focused on further experimentation with program delivery. We successfully held our in-person "welcome back" program in February 2022 (attended by 57). In May, we had our first hybrid program and are committed to further program delivery experimentation to serve our full Carolinas membership and beyond. We have exceeded our attendance goals to date by more than 50 percent, tracking to exceed 500.

## CONNECTING WITH OUR MEMBERS PURPOSEFULLY

Virtual meetings enabled us to deliver quality educational events, but virtual breakouts were a poor substitute for personal connections and camaraderie at in-person events. As attendance outside the Carolinas increased, we needed a more purposeful approach to engaging Carolina members and subscribers to

ensure they returned when we reconvened.

We established a chapter data and analytics platform to track who attended chapter programs and aggregate what we knew about our members, subscribers, and guests. Simultaneously, we created a member engagement committee to act on the data. Earlier this year, we established a chapter LinkedIn page to connect with members.

Leveraging our member engagement capabilities, we introduced member-led director cohort discussions, which were initially, topic-focused virtual dialogues (e.g., succession, activists) among an intimate group of 10 directors. Recently, we identified geographic concentrations among the approximately 50 percent of primary chapter members outside Charlotte (serving five metropolitan areas within 100–200 miles) and are encouraging local director events. We kicked off at Hilton Head in May 2022 with a core group of 12 directors, who have since met for a self-facilitated cybersecurity exchange. We plan to use this as a model for Charleston and, potentially, Columbia or Greenville in 2023. We see a virtuous cycle of these members engaging with sponsored programs on a hybrid basis or driving to Charlotte. We have already exceeded our Carolinas member engagement goals by more than 20 percent, with an added 50 percent beyond the Carolinas.

### GROWING AND DIVERSIFYING OUR SPONSORS

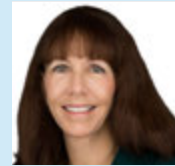
Our single premium sponsorship level encourages broad partnerships that provide valuable stability from the combined eight accounting and compensation firms that stood with us through the pandemic. Four new sponsors have since joined, bringing complementary benefits, law, risk, and online platform expertise—and giving us our most extensive, most diverse group ever. Multi-sponsor collaborations are adding a fresh dimension to our programs.

### STRENGTHENING OUR CHAPTER BOARD

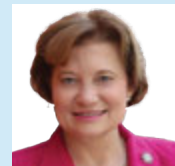
Our volunteer board has faithfully led the chapter through the crisis and is poised to drive its second decade. With two recent appointments, we are at our charter maximum (15) for the first time. We have intentionally built a diverse board, including five women and four people of color. A third of our chapter board is NACD Directorship Certified, with two more directors in process. Our combined executive expertise spans from entrepreneurs to major public companies, financial services to industrial, and all major C-suite roles. Our complementary expertise and networks enable us to deliver relevant chapter education and build community among Carolina directors.

Having used the past couple of years to experiment and build capabilities, we have emerged from the pandemic as a stronger chapter—and we are excited about the new opportunities ahead. ■

# NACD Chicago Chapter

**I**n the spring of 2020, the NACD Chicago Chapter, like the rest of the world, was forced to grapple with the new reality brought about by the worldwide COVID-19 pandemic. “With breathtaking abruptness, we had to pivot to the virtual world. It was a time of truly remarkable change,” recalled Paul Williams, board chair from 2017 to 2021.

The chapter’s reaction to the pandemic may be the most visible example of how it has consistently responded to members’ needs, but it is not the first. Since its founding, NACD Chicago has focused on continuous growth and improvement. In the last year, it formalized governance of the chapter by enhancing processes and policies, including streamlining financial operations to improve efficiency; expanded working committees; and increased the number of board members and chapter sponsors.

“We’ve worked hard to improve governance, the quality and timeliness of our programming, and to leverage the diversity of thought among our board members,” said NACD Chicago Board Chair Joan Steel. “We are engaging directors who have had tremendous business success to help take us to the next level.”

Current projects include enhancing the chapter’s social media profile and launching a data analytics project to better understand and address member needs.

The Chicago Chapter was established as an Illinois 501(c)(3) organization in 2001, under the leadership of Michele Hooper, who served as president for 16 years. It is one of the largest NACD chapters across the country, serving more than 2,000 members, including about 120 corporate board members and nearly 400 individual members. It supports 150 NACD Certified Directors and almost 100 Accelerate members.

The diverse chapter board comprises of 12 people, including eight women and five people of color. “Our chapter has always had board members who were committed to the mission of improving governance and devoted substantial time to the operation of the

chapter. I believe that our chapter has improved each year,” said Dennis Chookaszian, who serves on the board.

The chapter’s vision is to be the leading local source for advancing excellence in board governance and director effectiveness by offering engaging programming and networking opportunities for members in Chicago, Detroit, and Milwaukee.

Eleven sponsors support the chapter’s work. In addition to planning programs, they have generously contributed pro bono work to important chapter projects. “We consider our sponsors to be partners. Beyond financial support and subject matter expertise, they are essential to our growth. Their expertise helps us put the building blocks in place to unleash the chapter’s true potential,” Steel added.

The newly created program committee works with the chapter’s board directors and sponsors to develop relevant and compelling educational opportunities for members. “We work to incorporate an ESG approach, including diverse and prominent speakers in every program,” said Steel. “We try to bring the issues of the day to life by tackling the questions board directors need to ask and the kind of problem-solving they need to go through.”

According to Holly Van Deursen, who chairs the program committee, “Each sponsor works tirelessly with us on planning at least one event in the program year, and helps us deliver the best, and diverse, speakers or panels comprised of independent board directors, C-suite executives and subject matter experts. One of the best things about the Chicago Chapter is collaboration with our sponsors.”

Chookaszian notes that “while we are still focused on the broader governance issues, the scope of our programs and education process has expanded significantly to address the current environment.” A recent example of timely programming is last spring’s “pop-up” session on “Russia/Ukraine: Implications for Cyber and Supply Chain.”

During the height of the mergers and acquisitions (M&A) transactions in early 2022, the program on “The New State of M&A” ranked among the most successful. Within weeks of the new universal proxy rules going into effect, the chapter had a program with leading experts representing proxy solicitation, M&A advisory and legal counsel, in addition to a corporate board director who reached a settlement with activists.

Notable presenters in the Distinguished Speaker Series include Eric Artz, CEO of REI; Valerie Jarrett, former US presidential senior advisor and board director; Brad Keywell, cofounder of Groupon, and founder and CEO of Uptake; Mary Dillon, former CEO of Ulta Beauty; Craig Duchossois, CEO of Duchossois Group and daughter Ashley Duchossois Joyce, chair of The

Duchossois Family Foundation; and Peter May, president and founding partner of Trian Partners.

Site visits have included Accenture’s Chicago Innovation Hub and MxD, which promotes manufacturing and operates from a state-of-the-art innovation center. On a lighter note, the chapter participated in a live digital Broadway performance of the hit musical, *Hamilton*, including a conversation with cast and crew members. The member engagement committee also launched virtual happy hours for new members, complete with signature cocktails delivered to their doors.

“The NACD Chicago Chapter helps members stay informed and educated so they can maximize their performance as board directors at public and private companies in a constantly changing world,” Steel said. ■

Our chapter has a special connection to NACD. Colorful Colorado was home to the late Ronald I. “Ronnie” Zall, a Denver native, lawyer, and trailblazer in corporate governance, who with founding NACD President John Nash created the association’s original education programs. The “John and Ronnie” show traveled the country to provide director education to some of America’s leading corporations. Zall also authored our earliest publications on private company governance, family business governance, legal compliance, and director education. He served on NACD’s original advisory board for two decades and also on our local NACD chapter. During his tenure, he saw NACD grow from less than 100 to over 10,000 members before passing in 2017. That same year, the chapter established the Ronnie I. Zall Scholarship in his honor, recognizing Colorado directors who embody the following characteristics: (1) Active as a member of NACD—attends chapter programs and displays a high interest in director professionalism, (2) Active on a private, public company, or exempt organization board, and (3) Values pursuing director education and has expressed an interest in further director certification. To date, the following Colorado directors have been awarded with this distinguished award: Rose Robeson; Mike Fordyce; Marc Wallace; Jo Lynne Whiting, NACD.DC; Deb Kelly; Kate Paul; Teresa Van De Bogart, NACD.DC; and Susan Murphy. We are grateful to continue the Zall legacy in promoting good governance in our state.

## REACHING OUR NEIGHBORS

As a chapter, we continually seek avenues to leverage our success through collaborative opportunities and outreach. We routinely

reach out to all four corners of Colorado and to our neighboring states including Wyoming and New Mexico to invite their participation in our programs and activities. We are constantly looking out over the landscape to identify collaborative partners and cross-chapter relationships that can enhance our mission and serve our business community. An unexpected benefit of the pandemic for all chapters and NACD National was the ability to virtually expand the audiences for our programs across chapters. And for those NACD members who reside part time in Colorado, we embrace our second home community! Please check out our calendar before your next Colorado outing and join us!

## A FOCUS ON DIVERSITY

NACD is focused on driving more diversity in the boardroom. Our chapter board’s focus on diversity has created a very diverse board of 15 directors: five are women, two are African American, and two are Latino, and has set the bar high for other organizations. We made this effort a priority for our board and appointed an ad-hoc task force under the nominating and governance committee to support more diverse boards. It has culminated into several initiatives, including partnering with others in our community. Our collaborative partnership with the Women’s Leadership Foundation through their Boardbound Program has enhanced the presence of more women on Colorado boards and helps prepare women for board leadership to fill the pipeline for the future. This program year we are planning a half-day program in early 2023 focused initially on introducing diverse candidates to the profession of directorship and responsibilities for both corporate and nonprofit boards. The program will also serve to support NACD’s efforts to create a pipeline of diverse board candidates.

## NATIONAL INTEREST, COLORADO CONTEXT

In addition to focusing on key topics of broad NACD interest, our member programming explores those businesses and topics that are uniquely Colorado. For example, we hosted the CEO of Winter Park Resort to talk about the challenges and opportunities

he and his board faced throughout the pandemic. Challenges included sustaining a workforce in a high cost of living area, and environmental changes that are threatening the very industry itself. We also offered a fireside chat style program with the CEO of Ball Corp., John Hayes, who shared his perspectives on leading a multi-billion-dollar technology and aviation company home based in Colorado. We've also featured speakers representing other local and NACD full board member companies including Molson Coors, RE/MAX, Crocs, Western Union, and Delta Dental.

### 'OUT OF THE BOX' THINKING

In addition, during the height of the pandemic, on our website we featured articles highlighting several Colorado businesses who "pivoted" their business operations to sometimes completely new activities to support the communities impacted by COVID-19. Some Colorado companies featured on our website were Children's Hospital Colorado, Ent Credit Union, and Pop Sockets.

Monthly we provide at least one large scale mainstage program, inviting our entire 800-person footprint, plus an intimate 16-person roundtable dining experience that provides a forum for a deep dive on key issues facing organizations today. These are monthly education and networking events, allowing our directors to stay current on both Colorado and global corporate issues while collaborating with friends and new acquaintances on how to solve their individual board problems.

### SPRINKLING IN FUN

We also manage to have a lot of fun and pride ourselves in hosting quality networking events, including, for example, a half-day 9-hole golf and golf clinic event alongside PGA Reach followed by a presentation on obtaining your first corporate board seat. We also organized some unique member experiences. We spearheaded an extremely popular, multi-chapter virtual trip to Broadway for an exclusive, behind the scenes and selected performances experience of the Pulitzer- and Tony-winning musical hit production, *Hamilton*. Members attending virtually were able to "chat" interactively with each other during the show, which added to the fun. We also took our Colorado area members on a virtual wine-tasting escape to the Tuscany wine country, providing at home deliveries of a complimentary bottle. We are also planning for a multi-day program that will bring together private company directors that will conclude with participants having an opportunity to enjoy a ski experience in our wonderful Colorado Rocky Mountains.

Finally, we have put even more emphasis on welcoming new corporate board and individual members to our chapter. Through the efforts of our member engagement committee, we are meeting personally with our new members to introduce them to the organization and learn how we can best serve them.

For our chapter, the bottom line is to create value for our members and sponsors. We have put together a strong board of directors that strive for excellence in the areas of diversity, program excellence, and collaborative partnerships. We are a group who is passionate about advancing corporate board excellence. We look forward to welcoming you to one of our next mainstage or roundtable programs here in beautiful Colorado! ■

# NACD Florida Chapter

**T**he NACD Florida Chapter is known throughout the country for our strong programs that are laced with a touch of fun and fellowship. Some of our members are year-long Florida residents, while others are directors with a second home somewhere in the Sunshine State. We welcome all NACD members at our events throughout the state.

The NACD Florida Chapter was launched in 2005 and initially held meetings in South Florida—mostly in Miami and Fort Lauderdale—where the largest concentration of the state’s board leaders reside. However, after a few years, we expanded to offer programs in Tampa and Naples. In 2016, our chapter reenergized and diversified our board leadership, retained new administrators, and focused on chapter growth and excellence. At the same time, we restructured our sponsorship offerings and attracted experts in corporate governance as sponsors, many of whom have been with us for over a decade. Together, our board leadership and advisory board leaders (sponsor representatives) work closely to build our chapter and deliver outstanding programs throughout the year. Over the last six years, we have more than doubled our membership from 779 in 2016 to more than 1,721 today as the state has grown and our reputation has expanded.

Always willing to try something new, the chapter was a pioneer of creating “experiential programs” when we took members on a behind-the-scenes tour of Miami International Airport followed by a discussion with the CEO and two board members of American Airlines. Prior to the pandemic, we had launched a program to expand our programs and meet our members across Florida. We held Member Meet Ups in Boca Raton and West Palm Beach, Orlando, and Jacksonville meeting in the headquarter offices of several of our corporate board member companies. The Florida chapter was one of the first to launch virtual programming when the pandemic hit and created a small group Zoom “cocktail time” for members to interact and stay engaged after programs. As we delivered rich content virtually, we were able to greatly enhance our

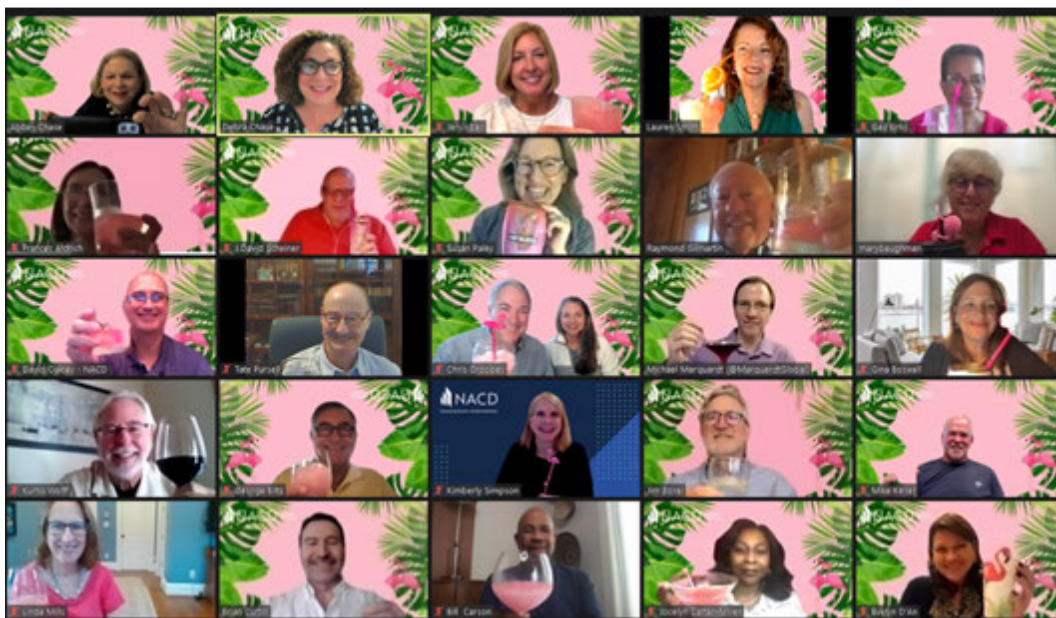

# NACD Minnesota Chapter

**S**teeped in a history of good governance, the NACD Minnesota Chapter was one of the original founding chapters of NACD. In 2002, our chapter became the fifth NACD chapter, when nationally there were less than 1,000 members. Two Minnesotans, accountant Bill Perron and attorney John Stout, met amid the tumultuous times of multiple corporate scandals, attributed in part to poor corporate governance. Both agreed on the importance of first-rate education for corporate directors to provide greater focus on their governance responsibilities.

Perron and Stout reached out to John Nash, the then president of a small but growing organization with a mission to improve board performance through rigorous director education (NACD). Nash was receptive to the creation of a chapter in Minnesota and in December 2002, the NACD Minnesota chapter was formed, with a geographic footprint including Minnesota, North and South Dakota, and Western Wisconsin.

Minnesota has a history of progressive governance promoted by the leaders of several of its large corporations. One of these leaders, Ken Dayton, was passionate about governance excellence and became a standard bearer for corporate stewardship. Dayton was then the president of the Dayton Corp., and later became the chair and CEO of the Dayton Hudson Corp. In 2000, Dayton Hudson Corp. changed its name to the Target Corp. And Target Corp. continues the standard for outstanding governance today. In 1987, one of Dayton's speeches was turned into a signal article called *Governance-Is-Governance*, which still stands the test of time. In it, he shared a conviction first that governance is clearly a discipline distinct from management and, second, that good governance in the nonprofit sector is equally as important as governance in the for-profit sector.

The blending of corporate leadership and nonprofit stewardship is a hallmark of companies in the Minnesota chapter footprint. The Twin-Cities (Minneapolis/St. Paul metro area) is home to more Fortune 500 companies per capita than any other metro area in the United States. Overall, there are nearly 35 Fortune 1000 companies in our footprint. Many of these companies are among the nearly 60 NACD-MN area corporate board members (public, private,

and nonprofit) that our chapter serves. Those companies include 3M Co., Best Buy Co., General Mills, Medtronic, Target Corp., US Bancorp, UnitedHealth Group. These combined with the nonprofit giant, Thrivent Financial, global private conglomerate, Cargill, and many privately owned businesses and nonprofits of all sizes makes our chapter rich with great companies.

Since we joined the NACD family in 2002, we've been on a purpose-driven path. Some leaders in our chapter footprint have risen to have an impact on the national level.

■ John Stout, our chapter cofounder, now an emeritus member of our NACD Minnesota board, continues to advance quality director education in our market. Early in the history of the chapter, Stout served on the national NACD board for two terms. He chaired the corporate governance committee of the American Bar Association's Business Law Section, he served as an expert witness on governance matters and locally he received the Twin Cities Business Outstanding Directors Lifetime Achievement Award for his corporate governance accomplishments. Today as a shareholder at a law firm, Stout serves as an adjunct professor, coteaches a governance course at a local law school, and frequently writes and speaks on corporate governance subjects.

■ Bill George is the former CEO and board chair of Medtronic, the world's leading medical technology company. George served on the NACD national board and in 2001, he was the NACD Director of the Year. George is now a professor at Harvard Business School and is an author. He served on several high-profile boards, including Target Corp., Novartis AG, Exxon Mobil Corp., the Mayo Clinic, and Goldman Sachs.

■ Reatha Clark King is a distinguished chemist, whose work with NASA helped make the Apollo 11 moon landing possible. An accomplished educator, she served as a professor at two universities and later as the president at Metropolitan State College in St. Paul, MN. She was a vice president at the General Mills Corp. and the former president, executive director, and chair of the board of trustees of the philanthropic foundation of General Mills. King served on many corporate boards including Exxon Mobil Corp.,

Wells Fargo, and Allina Health Systems. King served on the NACD National board and served as NACD board chair. In 2004, she was the NACD Director of the Year.

■ John Bergstrom is general partner and fund manager at Mairs & Power Venture Capital in St. Paul. He has served on boards of numerous private, public, and nonprofit organizations over his 30+ year career. John is a past board chair of the NACD Minnesota Chapter and also recently completed the NACD Director Certification. He was honored as an exemplary Minnesota board director in a Twin Cities Business awards ceremony on Sept. 21, 2022.

As our chapter continues its commitment to outstanding corporate governance and our role in helping to equip directors to be future ready, we are closing an exciting year. This year heralded in a new chapter president, executive director, and three new board members, all of whom are eagerly digging in to make a big difference for members we serve. Miron Marcotte, our board president, is a managing director at Protiviti, leading the Central Region with more than 30 years of experience providing audit and consulting services to companies in various industries. He has been

instrumental in helping the chapter chart an ambitious course and he recently completed the NACD Director Certification. # NACD New England Chapter

**T**he NACD New England Chapter is led by Board Chair Beth Boland and President Cathy Minehan, and a group of 23 directors who are prominent leaders in the region's corporate, civic, and philanthropic communities.

Officially, the NACD New England Chapter formed in 1996 but it was established before then with a handful of businessmen who believed in the importance of strong governance and the value of knowledge sharing with their peers. These individuals included Hal Shear, who is credited with bringing together the initial group that included Joe Caruso, Ed Pendergast, and Tom Sherwin, who was brought in shortly after to implement a robust programming schedule that brought the chapter to financial stability.

A critical juncture for the chapter came when Ed Pendergast learned about a Director of the Year program being run in Seattle and decided to bring it to New England. Despite the initial hesitancy of the chapter's board, Ed committed \$50,000 to hold the first NACD New England Chapter Director of the Year Awards in 2007. It turned out that this event was transformational to the financial health and public profile of the chapter. Aside from a two-year hiatus for COVID-19, the NACD New England Chapter has held its Director of the Year Gala honoring over 65 individuals and boards on their leadership in public, private, and nonprofit governance over the years.

In May of this year, we held our first awards gala since 2019 with a packed room full of attendees thrilled to celebrate in-person. The following individuals were honored: Jack O'Brien with Lifetime Achievement in Governance; Corey Thomas received the Leadership in Corporate Governance Award; Benaree Pratt Wylie received the Myra H. Kraft Award for Nonprofit Leadership; Boston Scientific received the Public Company Board of the Year;

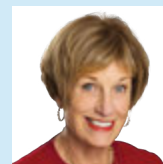

Within the framework of the NACD mission of empowering directors to be future ready, we look for opportunities for programs that do the following:

- are interactive, offering a forum for extensive member connection and dialogue;
- augment or challenge conventional wisdom, for example by bringing in speakers whose views may counter the mainstream; and
- explore local New York issues and developments.

Recent events have included discussions with experts across a wide range of key emerging director and governance issues, such as the following:

- **Environmental, social, and governance (ESG) issues.** The session explored the emergence of ESG-focused activist investors; the Paris Agreement; scope 1, 2, and 3 emissions; net zero emissions; reporting standards; Climate Action 100+; the Transform to Net

Zero coalition; and the Net Zero Asset Managers initiative.

- **Human capital dilemmas for today and tomorrow.** Attendees listened to how leading human resource teams are confronting the dilemma of managing labor shortages amid fears of inflation and a possible recession.

- **2022 regulatory enforcement trends.** This event offered a distillation of the different and more aggressive regulatory and enforcement approach of the Biden administration and the increasing regulatory expectations for disclosure on such emerging trends as ESG, cyber-

breaches, organizational culture, governance, and compliance program effectiveness.

- **The future of New York City tech.** The session explored what's next for NYC's tech sector, what makes the city unique as a technology center, and the appropriate role that directors can play in helping management traverse the many issues that will arise from the incredible growth taking place in NYC.

- **Digital currencies and blockchain.** Attendees dove into a discussion about Web3, emerging asset classes, and how leading institutions are considering the risks and opportunities associated with these developments.

Upcoming programming (in-person) includes explorations of crisis management, cybersecurity and the splintering of the global Internet, rethinking ESG, and economic forecasts. In an off-shoot of the NACD Battlefield to Boardroom initiative, we will also be hosting our annual seminar with graduates of the Army War College as they travel to New York City for interactive sessions with civilian leaders.

Our chapter's ability to continue to deliver world-class programming is supported by our stellar NACD New York sponsor community. We are gratified that over the last 18 months, we have

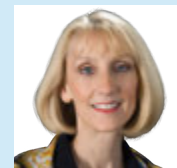

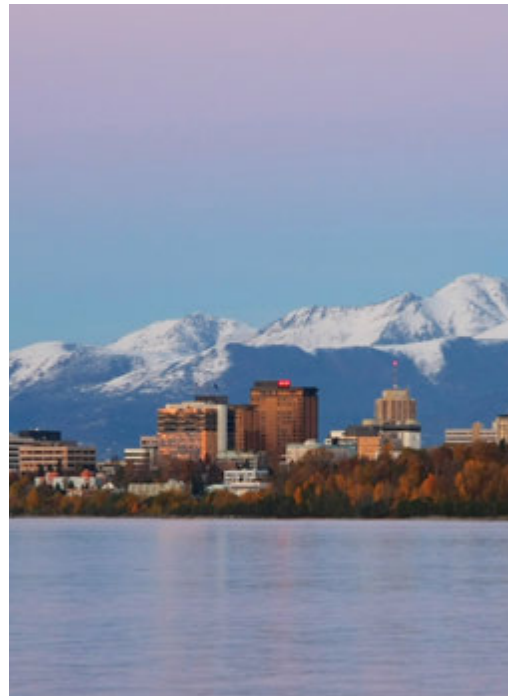

# NACD Pacific Southwest Chapter

**T**he NACD Pacific Southwest Chapter is a vibrant member of the national NACD chapter network. Founded shortly after NACD was founded, NACD Pacific Southwest has grown to become the fourth largest NACD chapter with almost 2,000 NACD member subscribers and growing. Our chapter region covers Arizona, Nevada, and Southern California, from Santa Barbara south to the international border.

Our chapter has a strong governance structure and succession planning with a 21-member board of directors representing our entire region, composed of serving corporate directors only. In addition to our chapter board, we have three regional advisory boards based in Southern California, Nevada, and Arizona. The regional advisory boards include prominent corporate directors, chapter board member emeriti, and sponsors, who enhance our chapter reach into the regional corporate director community and provide valuable feedback on program topics and speakers and how we can continue to enhance the NACD member experience and membership value.

The chapter board develops and executes innovative strategies through five active board committees led by chapter board members along with chapter ambassadors. The board committees include the programs committee, marketing and communications committee, member engagement committee, nominating and governance committee, and sponsorship committee.

NACD Pacific Southwest prides itself on producing world-class director education programs annually for NACD members, which has been the primary driver of the growth of NACD member subscribers to our chapter. We focus on programs by directors and for directors, with innovative and unique programming content examining current risk oversight topics with leading expert panelists. We try to produce director education programs that are unique and unavailable elsewhere. Of note, 1,237 members and guests across the United States attended NACD Pacific Southwest Chapter director education programs between September 2021 and June 2022.

For 15 years, in collaboration with local partners and NACD

national, NACD Pacific Southwest has cohosted an annual corporate director's symposium in Los Angeles, attracting upwards of 200 corporate directors to an all-day, multisession program, examining leading current governance topics. The next symposium will be held in the fall of 2023.

In 2017, the chapter initiated an ambassador program to engage chapter supporters in helping chapter committees execute on the chapter's and NACD's mission. The ambassador program has provided significant benefits to NACD Pacific Southwest since its inception, and many chapter ambassadors have subsequently been elected to the chapter board.

NACD Pacific Southwest also operates roundtable groups that are industry or board committee specific. Each roundtable convenes a curated group of seasoned corporate directors who meet quarterly and form rich relationships and is a forum for confidential conversations on current board issues and topics. Roundtables focus on compensation, financial services, health care, real estate, the nominating and governance committee, and general counsel.

## FUTURE INITIATIVES

NACD Pacific Southwest is creating and executing strategies to increase NACD awareness in and growth of member subscribers to the NACD Pacific Southwest Chapter. Our chapter region has comparatively few public companies headquartered here, and our

region business demographics show that many companies are primarily growth bioscience, technology, and private companies across all three states. Accordingly, we are pursuing outreach strategies to the bioscience, technology, and private company sectors in our region to promote NACD and the NACD Pacific Southwest Chapter as rich resources in governance that can assist in accelerating companies' economic development.

In support of growing the membership and the NACD brand as well as being future ready, we believe that it is important to also reach out, connect, and be relevant to the emerging growth company founders, CEOs, and board members in the 20-40 age group. Entrepreneurs are building multimillion-dollar businesses in their teens and early twenties. We are excited to support the successful acceleration and economic development of businesses across all three states, whether through targeted programming, strategic alliances with other organizations, or other resources including the rich thought leadership NACD provides to its members.

We are partnering with AZBio (the Arizona Bioindustry Association), a nonprofit organization representing more than 275 bioscience companies in Arizona, and participated in their annual white hat investor conference in September 2022. The conference and related awards and dinner ceremonies attract approximately 500 entrepreneurs, corporate directors, and investors, and we had a prominent position promoting NACD as the preeminent resource for board governance and education for

emerging growth companies and their economic development.

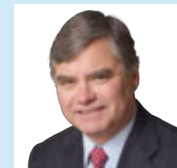
We are also developing strategic relationships in our local ecosystem with leading governance teaching and research academic institutions. Carey School of Business, one of the largest governance education and research academic institutions globally, which recently opened a satellite campus in Los Angeles.

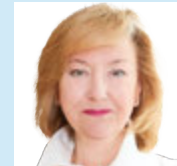

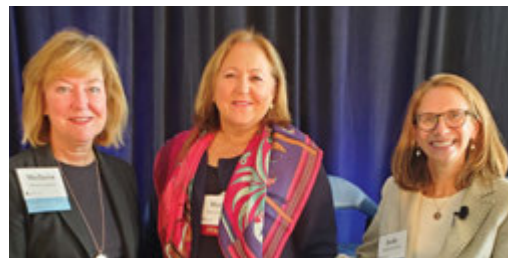

# NACD Research Triangle Chapter

The NACD Research Triangle Chapter's founders saw an opportunity. The region was entering a new stage of corporate growth in 2003, with its booming life science and technology industries. With more companies choosing to set up headquarters and research centers in the area, and more executive leaders choosing to live in Raleigh, Durham, Cary, Chapel Hill, and its surrounding areas, including near the coast, the chapter's founding members determined to make board governance education a priority.

The NACD membership in the chapter's footprint reflects regional strengths. Many are tech and life sciences directors and leaders with ties to world-renowned academic and research institutions, including Duke University, University of North Carolina at Chapel Hill, and North Carolina State University. These institutions and their strong alumni networks provide connections to corporations across the globe. In addition, the NACD Research Triangle Chapter serves a relatively large percentage of directors of private companies, either family-owned businesses or growth-stage companies that began as spinouts from one of the area's universities. North Carolina's growing prominence as a center for manufacturing is represented in the local NACD membership, which also includes board members from several large nonprofit research associations and health insurers.

Today, the chapter's board of directors, led by Bonnie Hancock, executive director of Enterprise Risk Management Initiative and professor of practice at NC State University's Poole College of Management, remain committed to promoting strong board practices and opening opportunities to previously underrepresented groups. The NACD Research Triangle Chapter has held forums addressing the governance issues of life sciences companies and privately held businesses, often in partnership with organizations

dedicated to increasing the number of women and people of color serving on corporate boards. Programs planned for 2023 will offer a focus on the tech sector, especially regarding start-ups moving from a founding board to a more mature fiduciary board.

Finally, the chapter remains a welcoming place both for experienced corporate directors and those aspiring to a first corporate board role. Skills training sessions and board basics often are

# NACD Texas TriCities Chapter

The Houston Chapter of the National Association of Corporate Directors, as it was called then, began in Houston in 2002 and later expanded into Austin and San Antonio to become the NACD Texas TriCities Chapter. In its early years and against the backdrop of the Enron Corp. and WorldCom scandals, the first of which was right in our backyard, it was a time to underscore the critical importance of corporate governance. In a Rice University classroom, a group of about 10 concerned corporate directors and service providers, including Vince Caraccio, Edgar “Bud” Geisinger, Vince Foster, Linda Spain, Chris Lafollette, and David Preng, convened for the first time with the common interest of starting a NACD chapter in Houston to educate and heighten awareness of excellence in corporate governance. A short time later in 2005, Ralph Hasson, NACD.DC, a director in Austin, expressed interest in creating a chapter there. In 2009 the chapter began hosting dinners in San Antonio and in 2011, the San Antonio Advisory Board came together under the leadership of Joe McKinney and Palmer Moe. We are so grateful to these founders and their vision and passion for corporate governance. The chapter also recognizes the tireless leadership of Kelly Dodd, Julie Pitts, and now, Jenn Cox as executive directors as well as Becky White who has served the chapter brilliantly for more than 11 years as chapter administrator.

In those early days in Houston, programs were held in a Rice University classroom and the attendance of 20 people was considered solid. Today, the chapter has 1,600-plus members in its footprint, hosts more than 25 programs annually across three

cities, has an active chapter board of 31 members, and advisory boards in all three markets. If you ask us about the secret sauce, we believe it’s all about connection, community, personal touch, and member outreach, supported by amazing staff, engaged sponsors, and director volunteers. We also believe in building fun into board and committee work as well as the member experience.

The COVID-19 pandemic threw everyone a curve ball, but also propelled us to innovate the delivery of director education while continuing to foster personal connection and relationships. Through technology we reached a far wider group of members both within and outside of our chapter footprint. The chapter also

created some new formats (in addition to virtual roundtables and webinars), one of which we called “Table for 5,” a virtual discussion with a panel comprising one of our chapter board members and four other directors. Through them, magic happened. In the first one, we gained a new sponsor partner and, in several others, we discovered members who wanted to engage more deeply with the chapter, many of whom are now on our chapter board and committees playing a vital role in the chapter’s success. Virtual wine tastings with members and committees were also a big hit.

By October 2021, chapter leaders were ready to be together again in person, so we hosted a happy hour with 30 chapter-leader attendees. After that, we experimented with returning to in-person programs starting with a peer-to-peer lunch, then hosted a couple of larger programs before having to retreat back to virtual events due to the Omicron variant. However, we came back strong in March of 2022, hosting our first-ever general counsel dinner

as well as an NACD Directorship 100 reception and a program in Austin and another in Houston focused on private company governance. In April, shortly after Russia invaded Ukraine, we hosted former Secretary of State James Baker who spoke to a crowd of 120 attendees in Houston. We've also adopted a paperless environment at our events, using QR codes for surveys and a tablet for the moderator to receive questions via text.

This past September, the chapter board attended an offsite strategic planning retreat at the Hyatt Lost Pines in Bastrop. In preparation, our membership committees personally reached out to more than 350 members for their input and the sponsorship committee held sponsor input sessions. Some great thinking and fellowship resulted. As we balance the need for in-person events with the success of virtual programming that reached a wider number of members, we know that it's time to consider the best combination of formats, locations, and program topics to add value for our members. It's clear that we

are living in a time of uncertainty. The only thing we know is that change will never be as slow as it's occurring today. Our chapter boards, like corporate boards, need resiliency, agility, and the ability to look around corners as well as embody the courage to experiment. In the words of Brené Brown, we must "dare greatly." ■

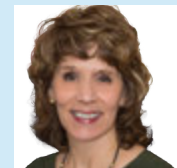

# NACD Utah Chapter

Chris helped organize a group of community leaders to determine whether a small market such as Utah could support an NACD chapter. That meeting led to a kickoff event attended by 31 people. Our chapter was off and running. One of the cofounders was Ron Poelman, who served as the initial chapter secretary and continues to support NACD, chapter awareness, and membership growth locally.

One of our first collaborations with the local community was to cohost a 2004 Directors & Officers Summit Conference. This collaboration is still going strong and we are a proud sponsor of the annual Utah Directors & Officers Summit Conference held each December in Deer Valley, UT. The conference annually draws more than 250 directors, officers, C-level executives, and others, and always spotlights the latest NACD Blue Ribbon Commission report.
